WHEREAS, the Commissioner of Public Works ("DPW") has advised that the New York State Department of Transportation ("NYSDOT") has approved an additional project for purchase of two pneumatic air compressors to State Comptroller's Contract No. K007393, for the period of April 1, 2018 through March 31, 2023, and

WHEREAS, by this Resolution, DPW seeks to amend Resolution No. 2023101 to add the additional project for the purchase of two pneumatic air compressors and to access allotted New York State funds, at no cost to the County as it is 100% State MEP funds, and

WHEREAS, no further funding is required under this Resolution, as the local share of the Public Transit projects has been obligated through prior Resolution No. 2023101, and

WHEREAS, DPW has determined that this project is classified as a Type II Action pursuant to Article 8 of the Environmental Conservation Law and Part 617 of the NYCRR (SEQR), will not have a significant impact on the environment, and as a Type II Action no further review is required, and

WHEREAS, it is necessary for this Legislature to authorize the County Executive or her designee to amend Resolution No. 2023101 by adding the additional project for the purchase of two pneumatic air compressors, as approved by New York State, now, therefore, be it

RESOLVED, that this Legislature hereby authorizes and empowers the County Executive, or her designee, to amend Resolution No. 2023101 to add the additional project for the purchase of two pneumatic air compressors.
