## RESOLUTION NO. 2025163

RE: AMENDING THE 2025 ADOPTED COUNTY BUDGET AS IT PERTAINS TO THE DEPARTMENT OF PUBLIC WORKS FOR FUNDING TO REPLACE THE WILCOX MEMORIAL PARK MOTOR FUEL TANK

Legislators METZGER, PAOLONI, D'AQUANNI, GORMAN, and CASWELL offer the following and move its adoption:

WHEREAS, the County is the owner of Wilcox Memorial Park located in the Town of Milan, and

WHEREAS, the Department of Public Works ("DPW") has proposed a project to replace the existing motor fuel tank at Wilcox Memorial Park (the "Project"), which is necessary to avoid a major leak as the tank is over 20 years old and is currently starting to leak, and

WHEREAS, the existing motor fuel tank at Wilcox Memorial Park contains both gasoline and diesel fuel and is used to fuel DPW-Parks Division vehicles and maintenance equipment as well as other Dutchess County agencies including the Sheriff's Office and the Office for the Aging, and

WHEREAS, DPW is seeking funding in the amount of \$100,000 to cover the costs for the Project which will include professional services, permitting, decommissioning and removal of the existing tank, purchasing and installation of a replacement above-ground gasoline/diesel tank, and

WHEREAS, DPW will properly register the removal and new tank installation with the New York State Department of Environmental Conservation (NYSDEC), and to the degree possible, salvage and re-use any motor fuels in the existing tank prior to its removal, and

WHEREAS, this proposed Project is a Type II action pursuant to Part 617.5(c)1 and (c)2 of the NYCRR ("SEQR"), requires no further environmental review, and will not have an adverse environmental impact, and

WHEREAS, it is necessary for this Legislature to authorize the establishment of a new capital project account which pertains to the aforementioned Project, and

WHEREAS, it is necessary to amend the 2025 Adopted County Budget to provide funds to meet these expenses, now therefore, be it

RESOLVED, that the Commissioner of Finance is authorized, empowered and directed to amend the 2025 Adopted County Budget as follows:
