RE: AMENDING THE 2025 ADOPTED COUNTY BUDGET AS IT PERTAINS TO THE DEPARTMENT OF PUBLIC WORKS FOR FUNDING TO REPLACE THE FIRE TRAINING BUILDING (BURN BUILDING) AT EMERGENCY RESPONSE

Legislators METZGER, PAOLONI, D'AQUANNI, GORMAN, and VALDÉS SMITH offer the following and move its adoption:

WHEREAS, the County is the owner of 392 Creek Road located in the Town of Hyde Park, and where the Dutchess County Department of Emergency Response is situated, and

WHEREAS, the Department of Public Works ("DPW") has proposed a project to replace the Fire Training Building (Burn Building) (the "Project") located at Emergency Response, and

WHEREAS, the existing Fire Training Building has been out of service for over a year due to its unsafe condition and would require extensive structural repairs to return it to service and still would not include many of the training features and props that are common in modern fire training facilities, and

WHEREAS, DPW is seeking funding in the amount of \$700,000 to cover the costs for the Project including demolition of the existing building and installation of a new modular fire training building that will include the necessary training props and features, and

WHEREAS, this proposed Project is a Type II action pursuant to Part 617.5(c)1 and (c)2 of the NYCRR ("SEQR"), requires no further environmental review, and will not have an adverse environmental impact, and

WHEREAS, if funding is authorized, DPW anticipates demolition of the existing building to be completed by December 2025, and the new modular fire training building delivered and installed in the Spring of 2026, with the facility placed back in service by June of 2026, and

WHEREAS, it is necessary for this Legislature to authorize the establishment of a new capital project account which pertains to the aforementioned Project, and

WHEREAS, an appropriation of the fund balance is necessary to provide funding for the aforementioned Project, and

WHEREAS, it is necessary to amend the 2025 Adopted County Budget to provide funds to meet these expenses, now therefore, be it

RESOLVED, that the Commissioner of Finance is authorized, empowered and directed to amend the 2025 Adopted County Budget as follows:

The Department of Public Works is requesting \$700,000 to replace the existing fire training building at the Department of Emergency Response, 392 Creek Road, in the Town of Hyde Park. The existing fire training building has been out of service for over a year due to its unsafe condition. The existing building has outlived its useful life and would require extensive structural repairs to return to service. Even if it were returned to service, the building does not have many of the training features and props that are common in modern fire training facilities.

The Department has received bids for demolition of the existing building, and for the installation of a new modular fire training building that includes the necessary training props and features. The cost summary is provided below:

If funding is approved, the Department will begin executing contracts in September 2025, and anticipates demolition to be completed by December 2025. The new modular fire training building will be delivered and installed in Spring 2026, with the facility placed in service by June 2026.

The project is a SEQR Type II action, per 6 NYCRR Part 617.5(c).1 and (c).2. No further environmental review is required.
