RE: AUTHORIZING COUNTY EXECUTIVE TO EXECUTE A
SUPPLEMENT TO THE GRANT AGREEMENT WITH THE
NEW YORK STATE DEPARTMENT OF TRANSPORTATION
(K007553) AND AMENDING THE 2025 ADOPTED COUNTY
BUDGET AS IT PERTAINS TO THE DEPARTMENT OF PUBLIC
WORKS – PUBLIC TRANSIT DIVISION

Legislators METZGER, PAOLONI, D'AQUANNI, GORMAN, and CASWELL offer the following and move its adoption:

WHEREAS, by Resolution No. 2024115, this Legislature authorized the County Executive to sign an Agreement with New York State Department of Transportation ("NYS DOT"), Comptroller's Contract No. K007553, which provided \$908,800 in Federal funding with State and Local matching requirements, for the period of April 1, 2023 through March 31, 2028, and

WHEREAS, the Commissioner of Public Works ("DPW") has been advised that the NYSDOT has awarded the County a Supplement to the Grant Agreement ("Supplement #1"), State Comptroller's Contract No. K007553, and

WHEREAS, this Supplement #1 will provide the ability to access all allotted NYS matching funds of previously obligated FTA 5307/5339 federal funds, in the amount of \$276,100, as set forth on the Schedule A1 annexed hereto, and

WHEREAS, no further County funding is needed as the local share of these projects has been obligated under Resolution No. 2024115, and

WHEREAS, it is necessary for this Legislature to authorize the execution of Supplement #1 and to amend the 2025 Adopted County Budget to accept such funds and provide for the receipt and expenditure of said funds, now therefore be it

RESOLVED, that this Legislature hereby authorizes the County Executive or her designee to accept this Supplement #1 grant award from New York State and further authorizes and empowers the County Executive or her designee to execute said Supplement #1 to the Grant Agreement, and any other documents necessary to receive such additional funds, on behalf of the County of Dutchess.

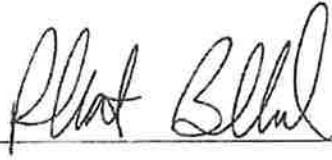
