RE: ESTABLISHING ZONE "029A" AND ZONE "029B" ZONES OF ASSESSMENT IN THE DUTCHESS COUNTY WATER DISTRICT IN THE TOWN OF HYDE PARK, DUTCHESS COUNTY, NEW YORK

Legislators D'AQUANNI and GORMAN offer the following and move its adoption:

WHEREAS, the New York State Legislature, by Chapter 592 of the Laws of 1991 (§1123, Public Authorities Law), created the Dutchess County Water and Wastewater Authority ("WWA"), and established the Dutchess County Water District covering all the areas within the boundaries of Dutchess County, and

WHEREAS, WWA has proposed to construct a water main extension to connect the existing Hyde Park Regional Water System to the existing Dutchess Estates water distribution system in the Town of Hyde Park, and

WHEREAS, WWA's ability to provide the referenced water services is contingent upon the creation of the two Zones of Assessment in the Dutchess County Water District encompassing all the properties in the said water system which will support those customers in the Town of Hyde Park, and

WHEREAS, WWA has presented to this Legislature a notice of project pursuant to Section 1124 of the Public Authorities Law which outlines WWA's plan to establish Zones "029A" and "029B" Zones of Assessment in the Dutchess County Water District for the extension to the Hyde Park Regional Water System, located in the Town of Hyde Park, and

WHEREAS, this Legislature has before it a Map, Plan and Report entitled "Map, Plan and Report, Dutchess County Water District Zones of Assessment "029A" and "029B"", which was submitted to it by the WWA with the Notice of Project pursuant to Section 1124 of the Public Authorities Law, and

WHEREAS, WWA proposes to enter into a Restatement of the Amended Service Agreement with Dutchess County (County), on behalf of the proposed Zones of Assessment "029A" and "029B" whereby the District will provide water services to the customers within the Zones at rates established by WWA, and

WHEREAS, the Map, Plan and Report identify the parcels to be included in each of the Zones of Assessment, describes the infrastructure to be used to provide water service, and provides the estimated annual cost for water service for the typical property in the proposed Zones of Assessment herein, and

WHEREAS, the first-year annual customer cost to the typical single-family home is estimated to be One Thousand, Three Hundred Twelve and 00/100 (\$1,312) dollars, and

WHEREAS, this Legislature conducted a public hearing on this proposal on October 14, 2025, and heard all persons interested, and

WHEREAS, the establishment of said Zone "029A" and Zone "029B" Zones of Assessment will ensure an economical, efficient water system for the properties within the service area, now therefore, be it

RESOLVED, that this Legislature hereby waives the notice provisions of Section 1124 of the Public Authorities Law and by this Resolution consents to this project, and be it further

RESOLVED, that it is hereby determined that the properties and property owners within the proposed Zone "029A" and Zone "029B" Zones of Assessment are benefited thereby and all the properties and property owners benefited are included with the proposed Zone "029A" and Zone "029B" Zones of Assessment, and it is in the public's interest to create the Zone "029A" and Zone "029B" Zones of Assessment, and be it further

RESOLVED, that the Zone "029A" and Zone "029B" Zones of Assessment in the Town of Hyde Park as aforementioned and more particularly described in "Attachment A" attached hereto is hereby established, and be it further

RESOLVED, that this resolution shall take effect immediately upon full compliance with all the requisite statutes and laws applicable to its adoption and promulgation.

RESOLVED, that this resolution is subject to permissive referendum.



Please find attached a Resolution Request Forms and Fiscal Impact Statements for two resolutions related to the creation of the County Water District Zone of Assessment "029A" and "029B" (Dutchess Estates Water).

The DCWWA is requesting that the County establish County Water District Zones of Assessment "029A" and "029B" to provide water services within the existing Dutchess Estates community in the Town of Hyde Park. The DCWWA is finalizing an agreement with the owner of the Dutchess Estates Water System to acquire the system at the point in time that DCWWA can provide an interconnection from its Hyde Park Regional Water System to the existing Dutchess Estates water distribution system. The interconnection is part of a larger project that connects the Hyde Park Regional and Quaker Hill Water Systems. A Map, Plan and Report for Zone of Assessment "029A" and "029B" was previously submitted for review. The DCWWA's ability to establish this new water service area is contingent on the creation of the Zones of Assessment within the County Water District, encompassing all properties in the System's service area. The DCWWA is asking the Legislature to pass two resolutions:


- Adoption of SEQR findings related to the Creation of County Water District Zone of Assessment "029A" and "029B", and
- Creation of County Water District Zone of Assessment "029A" and "029B"

The DCWWA intends to submit a resolution request under separate cover for the approval of the Restatement of the County Water District Service Agreement pertaining to Zone of Assessment "029A" and "029B" and including; Zones "030" and "031" as all Zones of Assessment pertain to the interconnection project between the Hyde Park Regional Water System and the Quaker Hill Water System. Said resolution request will be submitted prior to the December Committee and Legislature Meeting deadline.

Please find attached separate Resolution Request Forms and Fiscal Impact Statements for each of the two actions. In addition, please find Resolutions 2024087 and 2024088, which can be used as templates for these requested resolutions.

Jessica McMahon Deputy Director Treasurer On April 21, 2025, we sent you a letter to let you know that the Dutchess County Water and Wastewater Authority (DCWWA) had an on-going project to interconnect its Quaker Hill Estates Water System with its Hyde Park Regional Water System and wished to discuss the acquisition of your community's water system and include it as part of this project. A public meeting was held on May 13, 2025 that discussed this project, which can also be found on our website at https://www.dutchessny.gov/Departments/Water-Wastewater/Graphics/Projects-5-13-Dutchess-Estates-Water.pdf

The DCWWA is proposing to move forward with the project and, as a necessary step to accomplish the project is now working with the County Legislature to create a new Zone of Assessment (water service area) in the County Water District.

It is proposed that the Zone of Assessment will be created to provide for the extension of a 12" water main that will bring water service along Route 9G and interconnect your water system with the Hyde Park Regional Water System. The source of water for the new service area would be DCWWA's Hyde Park Water Treatment Plant — a water filtration plant that draws water from the Hudson River. Historically, water supplied by the plant consistently meets all safe drinking water standards.

If approved by the County Legislature, your property would be included in the Zone of Assessment. All developed properties currently connected to central water within your community and within the Zone will automatically be interconnected to the 12" water main. All properties within the Zone that are not currently connected to central water within your community would have the right to connect to the water main once the DCWWA assumes ownership of the distribution system. All properties within the zone will be assessed annually for the debt service expenses to repay the money borrowed to construct the line, once construction is complete and/or once DCWWA assumes ownership of the distribution system. Property owners not currently connected to central water that choose to connect to the water line would also pay a one-time service connection fee (more details on costs below).

Please be aware of the following important dates:

October 14, 2025 – Public Hearing before the full Legislature to receive comments from the public on the Zone of Assessment creation. The meeting will start at 6:30 PM. Any member of the public may speak at the public hearing.

Summary of Property Owner Costs

If the Zone of Assessment is approved by the County Legislature all property owners within the Zone would be assessed annually for the capital debt expense to construct the water line. This assessment of the capital debt expense will not occur until such a time your community is connected to the Hyde Park Regional Water System. Once connected, this charge would appear on the annual County/Town property tax bill. The amount of the annual tax is based on the type of property and expected water demand. The annual assessment would be in place for the life of the borrowing to construct the main. The capital assessment is charged regardless of whether the property owner chooses to connect to the water main.

Each property NOT currently connected to central water that chooses to connect to the water main would be responsible for their own costs to connect to the new water main, including installation of the service line from the main into the building, and the applicable DCWWA Water Service Permit Fee. These costs will vary from property to property, depending on factors such as which side of the road the property is on compared to the water main, distance from the main to the building, and presence of rock or other features that might impede excavation.

Each property that is connected to the water main will be billed quarterly for water usage. Currently, water meters are not installed on each individual building. A flat rate quarterly charge will be billed until such a time that each property has a water meter installed. Once meters are installed, each property will be billed quarterly based upon metered water usage. No quarterly usage billing is charged to properties that are not connected. Operating budgets and water usage rates are reviewed and approved annually by the DCWWA Board of Directors.

For a single-family residential property in your community that \underline{is} connected to the Hyde Park Regional Water System, the estimated annual costs are:

- Capital Assessment approximately six hundred and sixty-eight (\$668)
- Interim Water usage charged approximately one thousand one hundred and seventy-two dollars (\$1,172)

For a single-family residential property in your community that <u>IS NOT</u> connected to the Hyde Park Regional Water System, the estimated costs are:

- Annual capital assessment approximately six hundred and sixty-eight dollars (\$668)
- DCWWA Water Service Permit Fee a one-time fee of one thousand one hundred and fifty dollars (\$1,150.)
- Owner's cost to connect to the water main a one-time cost, varies by property.
