RE: DECLARING DUTCHESS COUNTY LEAD AGENCY AND ADOPTING DETERMINATION OF NO SIGNIFICANT ADVERSE ENVIRONMENTAL IMPACT IN CONNECTION WITH THE DEPARTMENT OF PUBLIC WORKS PROPOSED STRUCTURE DEMOLITION AND LAND RESTORATION PROJECT AT QUIET COVE RIVERFRONT PARK, BOWDOIN PARK AND WILCOX MEMORIAL PARK

Legislators D'AQUANNI and GORMAN offer the following and move its adoption:

WHEREAS, the County is responsible for the operation and maintenance of Quiet Cove Riverfront Park in the City of Poughkeepsie, Bowdoin Park in the Town of Poughkeepsie and Wilcox Memorial Park in the Town of Milan, and

WHEREAS, the Department of Public Works ("DPW") has proposed the Dutchess County Structure and Land Restoration Project (the "Project") which would involve the demolition of various buildings and structures as recommended in the 2020 Parks Master Plan, specifically within the structural assessment report of facilities, and

WHEREAS, DPW has prepared a Short Environmental Assessment Form which documents the environmental issues that have been investigated, and

WHEREAS, based on the foregoing, DPW has determined that the proposed project constitutes an Unlisted Action pursuant to Article 8 of the Environmental Conservation Law and Part 617.6 of the NYCRR ("SEQRA"), and will not result in any significant adverse environmental impacts, and

WHEREAS, a copy of the Short Environmental Assessment Form and the finding that the proposed action will not result in any significant adverse environmental impact is annexed hereto and made a part hereof, and

WHEREAS, it is the purpose of this Legislature in adopting this resolution, to adopt and confirm the above findings, and

WHEREAS, 6 NYCRR 617 requires the designation of a lead agency from among the involved agencies before a determination of significance can be made, and

WHEREAS, DPW has circulated the proposed action to all involved agencies for a thirty day period indicating its desire to be lead agency in accordance with 6 NYCRR 617.6, and no objection has been received, and it is the purpose of this resolution to establish Dutchess County as lead agency, which will directly undertake and coordinate this Project pursuant to the New York State Environmental Quality Review Act, now, therefore, be it

RESOLVED, that Dutchess County hereby assumes lead agency status for the Project and this Legislature hereby adopts and confirms the determination of the Dutchess County Department of Public Works that the proposed Project entitled the Dutchess County Structure and Land Restoration Project in the City of Poughkeepsie and Towns of Poughkeepsie and Milan, Dutchess County, will not result in any significant adverse environmental impacts.

This Notice is issued pursuant to Part 617.6 of the implementing regulations pertaining to Article 8 (State Environmental Quality Review Act) of the Environmental Conservation Law to designate a lead agency.

Dutchess County, through its Department of Public Works, is proposing to demolish certain abandoned structures at various Dutchess County parks as described in the attached Project Description. Work is proposed at three (3) different park locations, but the action is being considered as a single action for SEQR review.

The action has been determined to be an Unlisted Action, pursuant to the New York State Environmental Quality Review Act (SEQRA) 6 NYCRR Part 617. The Dutchess County Department of Public Works has completed Part 1 of a Short EAF, which has identified other involved agencies for the action.

LEAD AGENCY DESIGNATION

Under the applicable standards of 6 NYCRR Part 617.6(b), the County of Dutchess concludes that it should be designated as the lead agency in the coordinated environmental review of the action. IF YOU DO NOT RESPOND WITHIN THIRTY (30) DAYS, IT WILL BE INTERPRETED AS CONSENT THAT THE COUNTY OF DUTCHESS SERVE AS LEAD AGENCY. YOU WILL CONTINUE TO BE NOTIFIED OF SEQR DETERMINATIONS AND ANY SUBSEQUENT PROCEEDINGS AND HEARINGS, AS PROVIDED BY LAW.
