WHEREAS, the Dutchess County Sheriff desires to change the Civil Bureau hours in an effort to establish consistency of working hours and avoid overtime hours of staff stationed at the front desk at the Law Enforcement Center from Monday through Friday 9:00 a.m. to 5:00 p.m. to 8:00 a.m. to 4:00 p.m., and

WHEREAS, changing the hours of the Civil Bureau to Monday through Friday 8:00 a.m. to 4:00 p.m. will improve workflow within the Civil Bureau as well as provide the general public with time to conduct business in the Civil Bureau prior to typical working hours, and

WHEREAS, the Civil Accreditation Standards of the New York State Sheriff's Association requires that the Civil Bureau maintain business hours consistent with the provisions of New York State County Law Section 206, and

WHEREAS, pursuant to New York State County Law Section 206 (2) and Dutchess County Charter Section C-2.02(j), the Legislature may fix the hours that the civil office of the sheriff shall be kept open for the transaction of business and may fix the number of hours constituting a legal day's work for all classes of County employees and grant to the employing officer or board the power to stagger working hours, now, therefore, be it

RESOLVED, that this County Legislature hereby authorizes and changes the Civil Bureau hours from Monday through Friday 9:00 a.m. to 5:00 p.m. to Monday through Friday 8:00 a.m. to 4:00 p.m.
