RE: AUTHORIZING ALLOCATION OF AMERICAN RESCUE PLAN ("ARP") FUNDS AS THEY PERTAIN TO THE DESIGN, DEMOLITION, AND CONSTRUCTION MANAGEMENT OF A NEW DUTCHESS COUNTY YOUTH OPPORTUNITY CENTER TO BE LOCATED AT 35 MONTGOMERY STREET, CITY OF POUGHKEEPSIE

Legislators SAGLIANO, PULVER, BOLNER, CASWELL, PAOLONI, EDWARDS, LAWLER, JOHNSON, BRENDLI, LLAVERIAS, and ATKINS offer the following and move its adoption:

WHEREAS, the American Rescue Plan Act of 2021 ("ARP") provides fiscal recovery funds ("Funds") to county governments, as well as other forms of government, pursuant to US Department of Treasury Compliance and Reporting Guidance, for the purpose of alleviating the fiscal stress caused by the COVID-19 pandemic, and

WHEREAS, Dutchess County will receive ARP dollars sufficient to fund the cost of the following initiatives and/or improvements as outlined herein, and

WHEREAS, Dutchess County is committing TEN MILLION (\$10,000,000.00) DOLLARS in ARP funds towards the new Dutchess County Youth Opportunity Center in two Phases, and

WHEREAS, Phase I of the use of the ARP funds for the Dutchess County Youth Opportunity Center is authorized as follows:

a. The Commissioner of the Department of Public Works requests that ARP funding totaling EIGHT AND A HALF MILLION (\$8,500,000.00) DOLLARS be directed to finance the design, demolition, and construction management of the parcel located at 35 Montgomery Street, in the City of Poughkeepsie, formerly known as the YMCA, in order to develop a multi-purpose, state of the art youth and community center and facility with services for adult and youth education, arts, wellness, recreation, child care services, early learning, an indoor swimming pool, and youth activity center.

- i. Professional services for design of the new facility-TWO MILLION (\$2,000,000.00) DOLLARS
- ii. Professional services for construction management of the new facility-ONE MILLION (\$1,000,000.00) DOLLARS
- iii. Construction services to demolish the former YMCA building situated on the subject property and return the property to open green space-FIVE AND A HALF MILLION (\$5,500,000.00) DOLLARS

WHEREAS, Phase II of the use of the ARP Funds in the amount of ONE AND A HALF MILLION (\$1,500,000.00) DOLLARS for construction services for building the new Dutchess County Youth Opportunity Center, will be appropriated in a future resolution before this Legislature, once the Department of Public Works obtains a schematic design and estimate from a Consultant in accordance with County policy, and completes a site specific review for SEQR purposes, and

WHEREAS, this \$10,000,000 commitment from ARP funds is part of the up to \$25,000,000 that the County has committed to be spent on this project—the remaining \$15,000,000 of which will be presented in a future bond resolution to this Legislature in accordance with the terms of the contract of sale, and

WHEREAS, with regard to demolition, in the case of compliance with the provisions of the State Environmental Quality Review Act ("SEQR"), necessary review has been performed determining that this is an unlisted action necessitating coordinated review with Dutchess County as Lead Agency, and that the project will not have a significant impact on the environment, and

WHEREAS, in regard to design and construction management, these are SEQR Type II action and require no environmental review, and

WHEREAS, it is necessary to create a capital project account to receive the funds from the ARP to be appropriated for Phase I of the new Dutchess County Youth Opportunity Center, now therefore, be it

RESOLVED, that the Commissioner of Finance is authorized, empowered and directed to create the capital project accounts as follows:

- RE: REVISION 2 Resolution Request to authorize the use of American Rescue Plan (ARP) funds for costs to a new Dutchess County Youth Opportunity Center to be located at 35 Montgomery Street, City of Poughkeepsie

This resolution seeks to allocate \$10 million of ARP funds for a Youth Opportunity Center. The Department of Public Works is requesting authorization to use ARP funds to pay for the following expenses related to a proposed Dutchess County Youth Opportunity Center, to be located at 35 Montgomery Street, City of Poughkeepsie:

- Professional services for design of the new facility estimated at \$2.0M
- Professional services for construction management of the new facility estimated at \$1.0M
- Construction services to demolish the former YMCA building situated on the subject property and return the property to open green space estimated at \$5.5M

A SEQR review of the demolition project has been completed by the County, acting as Lead Agency. The review concluded that there is 'No Significant Adverse Environmental Impact' as a result of the demolition project. Authorization of funding for design and construction management costs is a SEQR Type II action and requires no environmental review.

The Department of Public Works obtained an estimate of probable demolition costs from a consultant architect in order to comply with the County's policy with regard to capital building projects.

When design and estimates are finalized, the balance of the \$10 million commitment of ARP funds to the project will be submitted to the Legislature for approval along with any other County funds necessary for the construction project. Attached to this memo are the following supporting documents:
